

Special in this tender

- New procurement process -> requires: dynamics for both internal organization and market parties
- Complexity of procurement (Stakeholders-Clusters-Chain)
- The parties are likely to fall back on traditional Client-Contractor roles
- Negotiations upcoming contracts (intensive process: in preparation and reporting)
- Working groups including market parties (Open ecosystem)
