## ■ Mission and Goals

GSV's work is based on the conclusion that any further growth of transport of goods and people will have to be largely decoupled from the growth of available space for transport infrastructure. Better use of existing transport infrastructure, efficient interfaces between transport modes, intelligent transport systems and innovative financing ideas for building and maintaining a sustainable multimodal transport infrastructure are in the focus of our work.

### In particular GSV is supporting

- Provision of adequate financial resources for maintaining an efficient transport infrastructure. Innovative financing tools have to be considered.

- Implementation of Intelligent Transport Systems as a basis for efficient transport management both serving the needs of industry and of travelling citizens. Relevant and reliable information is key to this process.
- Recognition and further development of the strengths of each single transport carrier and create optimum conditions for switching from one transport mode to another.

- Results are disseminated to opinion leaders and media.
- Fact sheets – presentation and dissemination of Facts and Figures on important topics including recommendations for action.
- Lobbying the goals of GSV and its members at related political institutions, the media, NGOs and other interested parties.
